This commitment is ingrained in our core value of caring and we aim to demonstrate these responsibilities through our actions and within our corporate policies.

We support our local community with equipment, volunteering or funding to give back to the locality which sustains us.

Conscious of Marco's role in supplying equipment which uses energy in food service locations across the globe, we invest in technologies which place us better than any other in our field at conserving energy and protecting the environment.

We support our staff, the Marco community, with health and wellness initiatives, a bike-to-work scheme and a belief that a healthy work-life balance for all our employees is best for Marco and our community. With over a decade of being a global leader with our ECOBOILER and MIX product ranges, we recognize the responsibility to ensure each new product results in a reduction of energy consumption throughout its lifetime, compared to best-in-class models. We specify 100% recyclability on all our plastics.

We manage end of life in line with the WEEE (Waste Electrical and Electronic Equipment) initiative. We design recyclable material into our product packaging.

Business Ethics and Transparency

Marco is committed to maintaining the highest standards of integrity and corporate governance practices in order to maintain excellence in its daily operations, and to promote confidence in its governance systems.

As a global supplier to customers worldwide, Marco operates across a diverse range of cultures and international markets. We are proud of our commitment to apply fair labour practices, while respecting the national and local laws of the countries and communities where we operate and are committed to providing equal opportunity in all aspects of employment.
